All the registered candidates for the said Examination are advised to visit the website (<https://jeemain.nta.nic.in/>) and verify their particulars. They are further advised to make correction/s in their particulars, in their respective Application Form, if required.

The candidates are allowed to make the corrections, latest by **02 December 2025** (up to 11:50 P.M.). Thereafter, no correction in particulars, whatsoever, will be entertained by NTA under any circumstances. The additional fee (wherever applicable) shall be paid by the candidate concerned either through **Credit/Debit Card/Net Banking/UPI**.

Since it is a one-time facility extended to the candidates to avoid any hardship, the candidates are advised to do the correction very carefully, as no further opportunity for correction will be given to the candidates.

5.	Candidates shall be allowed to <b>change all the fields</b> :	i. Date of Birth ii. Gender iii. Category iv. Sub-category/PwD (If not verified by UDID Portal) v. Signature
6.	Candidates shall be allowed to add the field:	i. Paper
7.	Candidates shall be allowed to change identity details (Only for candidates who registered with identity other than Aadhaar):	i. Aadhaar details
