Subject: Declaration of results of UGC-NET December 2025 - reg.

1. The UGC-NET December 2025 examination was conducted by National Testing Agency for 85 subjects in computer-based test (CBT), mode. The examination spanned over 06 days and was conducted in 11 shifts at 663 exam centres in 283 cities across the country for 9,93,702 candidates, as per the following details:

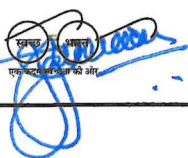
4. The result of UGC-NET December 2025 examination is being declared today i.e. 04.02.2026.

6. Measures for Smooth & Fair Conduct of Examination:

A control room was opened in the NTA premises where Virtual Observers were deployed for monitoring of live CCTV of all examination centres in India. A total of approximately 41,500 cameras were installed. In order to stop cheating using mobile networks, jammers were installed in all the centres to prevent unfair practice by the candidates during the examination. approx. 52,500 jammers in all shifts were put in place.
