- SC, ST, OBC (NCL) CENTRE LIST, EWS candidates, who would be finally selected on their own merit without relaxed standards/concession (except fees), will not be adjusted against the reserved share of vacancies. Such candidates will be accommodated against the Unreserved vacancies earmarked for UR category. The reserved vacancies will be filled up separately from amongst the eligible SC, ST, OBC (NCL) CENTRE LIST and EWS candidates.
- SC, ST, OBC(NCL) CENTRE LIST and EWS candidates who qualify on the basis of relaxed standards viz age limit, experience or qualifications, extended zone of consideration (cut of marks) etc., irrespective of his/her final merit position, is to be counted against reserved point and not against unreserved vacancies.
- The Board reserves the right to decrease the shortlisting criteria/cut-off marks for Tier-II/Interview/Skill Test, as the case may be in case the requisite number of candidates is not available in OBC/EWS/SC/ST/PwBD categories. The Board further reserves the right to fill, not to fill or partially fill any of the advertised vacancies due to administrative reasons and also reserves the right to cancel/modify/alter the recruitment process, if required. The Board shall reserve the right to shortlist the candidates based on merit, experience, written and/or skill test, as the case may be and also reserve the right to change/amend the examination scheme, if so required, any time before the examination. The Board reserves the right to fix criteria viz; screening test/qualification/experience etc. to shortlist the candidates to be called for Tier-II/interview/skill test due to administrative reasons.
