1. The Central Board of Secondary Education (CBSE), vide Advertisement No. CBSE/Rectt.Cell/14(88)/2025 dated 02.12.2025, had invited applications for Direct Recruitment Quota Examination 2026 (DRQ2026) for the following posts:

5. On the basis of marks secured by the candidates in the OMR-based Objective Type Test and Descriptive Paper of the Tier-II Examination, and in accordance with the criteria prescribed in the aforesaid advertisement, candidates (not in order of merit) have been provisionally shortlisted for the next stage of the recruitment process, i.e., Interview for Group 'A' posts and Skill Test for Group 'B' & 'C' posts. However, for the post of Junior Translation Officer (07/25), the recruitment process comprises only a two-tier examination.

On the basis of performance of the candidates in Tier-II Examination only, candidates have been shortlisted against 101 vacancies out of the 124 vacancies advertised for the next stage of recruitment, i.e., Interview for Group 'A' posts (Post Codes 01/25 to 05/25) and Skill Test for Group 'B' posts (Post Codes 06/25, 08/25 & 09/25), in accordance with the relevant provisions of the advertisement notification dated 02.12.2026. The remaining 23 vacancies could not be filled due to non-availability of eligible candidates. The details are as follows:

The above table indicates the actual vacancy position after applying the mandatory qualifying criteria of 30% marks in Tier-II examination and the prescribed shortlisting ratio of 1:5 for Interview/Skill Test. In cases where sufficient candidates were not available, the corresponding vacancies could not meet the prescribed shortlisting ratio and may remain unfilled.								

7. Candidates may check/view their DRQ2026 (Tier-II) result by logging in with the same credentials as used earlier.

8. The candidature of all shortlisted candidates is purely **provisional**. Mere inclusion of Roll Number and Name in this Result Notice does not confer any right upon the candidate for appointment to the post. Verification of eligibility conditions/documents will be undertaken at subsequent stages. The Cut-off marks of DRQ2026 (Tier-II) is as given for the respective posts:

9. SC, ST, OBC (NCL) CENTRE LIST, EWS candidates, who would be finally selected on their own merit without relaxed standards/concession (except fees), will not be adjusted against the reserved share of vacancies. Such candidates will be accommodated against the Unreserved vacancies earmarked for UR category. The reserved vacancies will be filled up separately from amongst the eligible SC, ST, OBC (NCL) CENTRE LIST and EWS candidates.
10. SC, ST, OBC (NCL) CENTRE LIST and EWS candidates who qualify on the basis of relaxed standards viz age limit, experience or qualifications, extended zone of consideration (cut off marks) etc., irrespective of his/her final merit position, is to be counted against reserved point and not against unreserved vacancies.
11. The Board reserves the right to decrease the shortlisting criteria/cut-off marks for Interview/Skill Test, as the case may be in case the requisite number of candidates is not available in OBC/EWS/SC/ST/PwBD categories. The Board further reserves the right to fill, not to fill or partially fill any of the advertised vacancies due to administrative reasons and also reserves the right to cancel/modify/alter the recruitment process, if required. The Board shall reserve the right to shortlist the candidates based on merit, experience, written and/or skill test, as the case may be and also reserve the right to change/amend the examination scheme, if so required, any time before the examination. The Board reserves the right to fix criteria viz; screening test/qualification/experience etc. to shortlist the candidates to be called for interview/skill test due to administrative reasons.
12. It is informed that while every effort has been made to ensure accuracy in preparing the result, the Board reserves the right to rectify such errors and omissions, if detected at any stage. The total number of vacancies and the reserved vacancies are provisional and may vary according to the actual requirements. The reservation under various categories will be as per prevailing Government of India's guidelines at the time of finalization of result.
13. Decision of the Board in all matters regarding Recruitment Process/Eligibility of the candidate/the documents to be produced/conduct of Interview/Skill Test and any other matter relating to recruitment will be final and binding on the candidate.
14. The date(s), schedule and venue for the Interview/Skill test (as per the applicability) will be notified in due course on the official website.
